### **PRIVACY POLICY**

Deeya Panel Products Private Limited ("Ricron" / "we" / "us" / "our") respects the privacy of all the users who use ("Users" / "you" / "your") its website www.ricron.com ("Website"). Ricron is committed towards protecting and safeguarding the personal information of its Users which may be collected by Ricron in consequence of your use / access / browsing of the Website. Any personal information collected from You on the Website shall be governed by this privacy policy ("Privacy Policy"). This Privacy Policy provides for the nature and type of personal information collected on the Website, the manner in which it is collected, use of such information, and disclosure and handling of such information by Ricron. The Users are advised to read this Privacy Policy, along with our Terms of Use ("Terms"), before using / accessing / browsing the Website and providing Ricron with their personal information.

### 1. **GENERAL**

- 1.1 The collection and processing of information in the course of other contractual or commercial engagements that we may enter into with you, will be done in accordance with the specific terms applicable thereto, and not by this Privacy Policy.
- 1.2 By using / accessing / browsing or by otherwise giving us your information, you confirm that you have the capacity to enter into a legally binding contract and that you have read, understood and agreed to the practices and policies outlined in this Privacy Policy and our Terms of Use (together the "Agreement"). You hereby consent to our collection, use, sharing, and disclosure of your information as described in this Privacy Policy.

# 1.3 Change in Privacy Policy

Ricron is committed to comply with the extant applicable laws of India. Ricron reserves the right to amend, modify, add, delete or remove any portion of this Privacy Policy as required under any applicable law or if required to enhance and improve the Users' experience of its Website. Usage of your personal information shall be governed by the last updated or revised Privacy Policy which shall be available on the Website. Your continued use / access / browsing of the Website after any such amendment or modification signifies your acceptance to such amendment or modification. If you do not agree with this Privacy Policy at any time, in part or as a whole, you may not use / access / browse the Website or provide us with any of your Information.

### 2. INFORMATION BEING COLLECTED

If you provide us with User Information of third parties, we understand that You have obtained consent of such third parties, and have sufficient rights, approvals and licenses to provide such information to us.

#### 3. CONSENT

3.1 The IT Act and the SPDI Rules regulate the collection, usage, retention and disclosure of personal information, which is defined under the SPDI Rules as any information that relates to a natural person, which, either directly or indirectly, in combination with other information available or likely to be available to a body corporate, is capable of identifying such person ("Personal Information"). Some of the Information collected by us may qualify as Personal Information.

- 3.2 By using / accessing / browsing the Website, you acknowledge and agree that all Personal Information provided by you to us is voluntarily which can be used in accordance with this Privacy Policy. Ricron does not sell or trade in any form or manner, the Personal Information of its Users to any third party.
